Boarding Terms & Conditions (Summary)

- Pets must be fully vaccinated by law. Valid documentation must be presented at check-in. Failure to do so may result in refusal of entry and loss of deposit.
- Canine cough vaccination is recommended but not compulsory. No responsibility is accepted if contracted.
- Pets must be up to date with worming (every 3 months), heartworm, flea and tick treatments.
- Pets with chronic conditions, recent surgery or senior pets should have a veterinary fitness-to-stay check within 10 days prior to boarding. No responsibility is accepted for pre-existing or age-related conditions.
- Females in season are not accepted.
- Any additional costs (vet visits, food, treatments) must be paid in full before collection.
- In emergencies, owners authorise Diggers Den to seek veterinary treatment if they cannot be contacted. All costs are the owner's responsibility.
- A non-refundable 50% deposit is required to secure bookings; balance payable on arrival.
- Cancellation policy applies as per published terms (high and low season rules).
- Boarding is charged per day. Collection before 11:30am is free; later collections incur an additional day.
- Diggers Den holds public liability insurance up to €150,000 (excluding pre-existing conditions).
